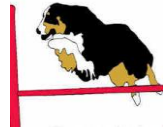

The sit and down stay exercises for all Regular Novice classes and all Regular Open classes will be **before** the individual exercises. Order of classes will be Open sit and down stays, Novice sit and down stays, Novice A and B individual exercises, Open A and B individual exercises, Utility A and B, Wildcard Utility, Wildcard Open and wildcard open sits and down stays, Wildcard Novice and wildcard novice sit and down stay, Pre-novice.

HIT is awarded to the highest scoring dog for each trial.

HIT-Aussie awarded to the highest scoring Aussie for each trial.

All dogs six (6) months and older must have an individual ASCA registration or LEP number or an ASCA tracking number to compete in ASCA sanctioned Obedience/Rally Trials. A dog will be allowed to be shown at the trial where the handler applies for an ASCA tracking number. The handler will be issued a receipt by the Registration table valid for sixty (60) days to allow the Business Office time to issue the tracking number. Photo copies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned Obedience/Rally Trials. Each non-ASCA registered dog will be required to have an ASCA Tracking Number. This is a one-time fee of \$10/dog. At the time of applying for the tracking number, the individual owner must also be an ASCA member (minimum membership type of Service is required). ASCA membership does not need to be maintained in subsequent years.

If your dog does NOT have a tracking number fill out the form at the end of the premium. Then attach that form, and check or Money Order payable to ASCA to cover tracking fee, to your entry.

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA rules and regulations. No entry shall be accepted which specifies any conditions as to its acceptance. Returned checks do not constitute a valid entry.

\*\*\*\*\* If your check is not paid on presentment or is dishonored, you agree to pay a service charge of \$25, or any higher amount allowed by law. We may electronically debit or draft your account for this charge. Also if your check is returned for insufficient or uncollected funds, your check may be electronically re-presented for payment. **Disclaimers:** This show/trial will be judged and run by the rules of the Australian Shepherd Club of America. Dogs must be ready for judging. Neither the club, judge nor show/trial secretary will be responsible or obligated to notify exhibitors or agents as to their class judging. Entry fees will not be refunded in the case a dog is absent, disqualified, excused or barred from competition by action of the show committee. No entry fee will be refunded if the show cannot be opened or completed by reasons of riots, civil disturbances, fires, acts of God or public emergency. The show giving club, show chairperson, agents, officers and/or committee shall assume no responsibility for injury to children. No bitches in season near the obedience/Rally OR agility rings. Judges may be substituted. All dogs must be on leash or crated, except when competing. No electrical or mechanical training devices permitted on show grounds. Clean up after your dogs. No selling of puppies and/or dogs on show grounds. Please notify show chairperson in case of conflicts. All dogs must be current on rabies, parvo and distemper vaccinations and/or have appropriate titer levels. Please bring a copy of rabies certificate. Regular-class Dogs must show proof of registration/tracking number with entry. Only dogs with ASCA CD or CDX will be allowed to enter Open or Utility classes. No exhibition only. Dogs entered in any Non-regular class other than Brace, Veterans, Wild Card, and the Team Non-regular classes shall not enter or exhibit in any Regular Obedience Class held at the same show and on the same day. ### TRIAL SITE DIRECTIONS

Coming from I-10 take the SR-85 exit (exit number 56) toward CRESTVIEW/NICEVILLE. Merge onto FL-85 N toward CRESTVIEW. Turn LEFT onto E JAMES LEE BLVD/US-90/FL-10. Continue to follow US-90 W/FL-10 W (4.2 miles). Turn SLIGHT RIGHT onto FL-4 (4.6 miles). You will continue on this road for 2.8 miles you see the Baker Area Recreation Association (Baker Arena) on your right.

**NOTICE NEW RV and TENT CAMPING POLICY:** RV and Tent Camping is \$18.00 a night, which must be PRE-PAID and postmarked by January 20, 2012 (so that it will reach me in time for the trial) payable to FLPHASC, electrical and water hookups, showers on site. In order to have ASCA® qualifying legs tracked and to receive ASCA® titling certificates, each non-ASCA® registered dog will be required to have an ASCA® Tracking Number. This is a one-time fee of \$10/dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (minimum membership type of Service is required). ASCA® membership does not need to be maintained in subsequent years. **It will be the responsibility of the owner to identify to ASCA® the show(s) and leg(s) earned when applying for a Tracking Number for those ASCA® qualifying legs earned from 1/1/2003 until submission of application.**

## ⇒ FREQUENTLY ASKED QUESTIONS ⇐

### Do I have to have a tracking number to compete?

No, you do not need a tracking number in order to compete in Agility or Stock.

You will need a tracking number to enter an Obedience trial or Tracking Test.

Your dog does not have to be a purebred to receive a tracking number from ASCA.

### Why would I need or want a tracking number for my dog?

If you would like to have your dog's points and titles recorded by ASCA, and if you'd like to receive title certificates in the mail for your accomplishments, you might want to obtain a tracking number.

### How much is the total cost for a tracking number?

In order to obtain a tracking number for your dog, you must be at least a "Service" member. The cost for Service Membership is **\$10**.

- Your membership is good for one year; however, it does not need to be maintained in subsequent years, unless you want to obtain another tracking number for another dog after your membership has expired.

This membership fee is **in addition** to the tracking fee of **\$10** per dog. A tracking number is good for the **lifetime of the dog**. If you only have one dog, the total cost would be **\$20**. For two dogs, the cost would be **\$30**, for three, the cost would be **\$40**, etc.
