Wednesday Ranch Trial starts at 12pm

Thursday and Friday Trials start at 8am followed by an arena trial.

There will be 2 arena trials on Saturday and Sunday. See arena premium for details.

Pre-Entries Open: 10/15/25, Pre-Entries Close: 11/19/25. Pre-entries must be mailed, not require signature.

Entries accepted by postmark date. **Day of Show** entries 7:45am if available on Thursday and Friday only.

Courses provided day of trial. Additional rules published in ASCA Stockdog rules.

We have had slow mail service. Entries have been lost or delayed. I suggest you use priority or email me to know you have mailed entries so I am looking out for them. We are still only accepting mailed entries by postmark.

Ranch trial titles only require one leg. Please enter only one trial for each stock. We are running three days if needed due to limitations in stock numbers. We will fill Thursday and Friday first and use Wednesday if needed for overflow. Please indicate your priority for days, if there is a day you cannot make, or if it does not matter.

Order of classes: Alternate cattle and sheep runs

Number of runs: 4 runs per class of stock. **Run order** drawn day of trial.

Allowed time is 20 minutes with a 10 minute and 3 minute warning. Bitches in heat will run in order.

Awards: Qualifying and 1ST through 4th placement ribbons for all classes. All trials will be conducted under the rules and regulations of the ASCA Stockdog program. Disputes must be brought to the immediate attention of the course director and will in all cases follow the dispute regulations outlined in the ASCA Stockdog rulebook, pages 76-83.
