Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA rules and regulations. No entry shall be accepted which specifies any conditions as to its acceptance. Returned checks do not constitute a valid entry.

SITE INFORMATION Containers and interior searches will be held indoors. Exteriors and vehicles will be outside, and may include walking on gravel and uneven surfaces. Competitors will need to crate out of their vehicles. There will be NO food concession on site. Snacks and drinks will be provided for workers.

Conflict Policy for FLPHASC: If you have a conflict notify ring steward and put a C by your dog's name at each conflict ring. We will try to be accommodating, but we must know you have a conflict and we must make sure that the competitive experience for all exhibitors is equitable for all involved.
